Calves :

Via dosing pumps or directly mixed in drinking water :

- From 3 days old 25 ml / day / animal to 10 days old.
- Double dose if digestive troubles persist or appear from the 5th days of life.
- Older calves : 50 ml / day / animal during 5 days.



Lambs and kids :
